## Course Outline and Structure

### Training Delivery

Training is delivered via **Blended (face to face and online distance learning) + Vocational Placement** to be completed in up to **65 weeks (including holidays)** with approximately **1,416 hours** of study, depending on learner's skills, knowledge, and experience.

### Assessment Methods:

- **Observation** during on-the-job or role play/ simulation
- **Questioning** may include self-assessment, verbal answers, written questionnaires, activity modules or interview
- **Third Party**
- **Structured Activities**

### What are the entry requirements?

There are no prerequisites required to enter this course. However, it is preferred that students:

- must be 18 years or older
- Have sound language, literacy, and numeracy skills\* (at least Year 10 English, or equivalent)
- Have basic computer skills
- Must hold a current **Student Visa**
- **(From non-English speaking background)** are required to provide any one of the following evidence of upper intermediate proficiency in English:
  - ◆ IELTS total band score of at least 6.0 with no band less than 5.5, or equivalent.
  - ◆ Occupational English Test (OET), TOEFL Ibt, Pearson Test of English, Cambridge English
  - ◆ *Advanced with scores equivalent to IELTS 6.0 and no less than 5.5 in each band.*
  - ◆ *The English test must have been taken within two years before the application is made.*

*\*Students who fail the LL&N assessment may still be enrolled to a course if endorsed by the trainer/assessor, and corresponding additional support strategies are in place.*

## Course Resources

## Is Recognition of Prior Learning (RPL) available?

Melvic College Australia has a Recognition of Prior Learning (RPL) Policy, to ensure that an individual's prior learning, achieved through formal and informal training, work experience or other life experiences, is appropriately recognised. This recognition may assist Learners to progress faster through a unit of competency, or allow the student full credit for a unit of competency.

Any course duration reduction as a result of RPL granted to international students will be indicated on the Confirmation of Enrolment if granted prior to the issue of a visa or on PRISMS if granted after the issue of a visa.

## Provide first aid (HLTAID011):

Separately, learners are required to complete the First aid unit (HLTAID011) prior to commencing vocational placement. Melvic College Australia facilitates its own workshop for this course. Learners may attend the workshop at any point during the course as long as it is before they go on vocational placement. They will receive a separate Statement of Attainment for this unit of competency upon successful completion of the training course.

## What are the qualification pathways after taking the course?

Students enrolled in this course may also choose to study other courses that will support them in their Individual Support skills. Other options available for students may include the following qualifications:

## Vocational Placement

Learners are required to undertake a minimum of **120 hours** of vocational placement within a registered and approved aged care centre. This must occur after the student has satisfactorily completed all the other units/subjects in this qualification.

During this time, the learners are required to complete a skills workbook.

Learners have the option to:

- have their Vocational Placement under one of Melvic College Australia's partner organisations:
  - O St. James Terrace Aged Care**
    - Location: 294-296 Warrigal Rd Cheltenham VIC 3192
      - Can accommodate eight (8) students per week; total of 208 students per year
  - O McKenzie Aged Care Group**
    - Location: 1 Innisfallen Ave, Templestowe VIC 3106
      - Can accommodate 40 students per week; total of 300 students per year
- source their own Vocational Placement providers (Melvic College Australia to check suitability); or
- have Melvic College Australia assist them in arranging Vocational Placement providers near their area.

For learners who plan to source their own Vocational Placement provider, **Melvic College Australia** will provide a **Vocational Placement Pack** that outlines all the requirements for finding a suitable provider that will facilitate the required workplace assessments and allow the learner to complete the required vocational placement hours. Learners are recommended to initiate contact with potential Vocational Placement providers as soon as enrolment is confirmed to allow sufficient time for Melvic College Australia to confirm the workplace's safety and suitability.
