## Course Outline and Structure

### Training Delivery

Training is delivered via **Blended (Face to Face + Online Distance) + Vocational Placement** to be completed in up to **78 weeks (including holiday break)** with approximately **1,469 hours** of study, depending on learner's skills, knowledge, and experience.

### Assessment Methods:

- **Observation** during on-the-job or role play/ simulation
- **Questioning** may include self-assessment, verbal answers, written questionnaires, activity modules or interview
- **Third party**
- **Structured Activities**

### What are the entry requirements?

There are no prerequisites required to enter this course. However, it is preferred that students:

- must be 18 years or older
- Have sound language, literacy, and numeracy skills\* (at least Year 10 English, or equivalent)
- Have basic computer skill
- Must hold a current **Student Visa**
- **(From non-English speaking background)** are required to provide any one of the following evidence of upper intermediate proficiency in English:
  - ◆ IELTS total band score of at least 6.0 with no band less than 5.5, or equivalent.
  - ◆ Occupational English Test (OET), TOEFL Ibt, Pearson Test of English, Cambridge English Advanced with scores equivalent to IELTS 6.0 and no less than 5.5 in each band.
  - ◆ The English test must have been taken within two years before the application is made.

*\*Students who fail the LL&N assessment may still be enrolled to a course if endorsed by the trainer/assessor, and corresponding additional support strategies are in place.*

## Is Recognition of Prior Learning (RPL) available?

# Course Outline and Structure

## Provide first aid (HLTAID011):

Melvic College Australia facilitates its own workshop for this course. Learners do not need to find a separate course provider. The schedule may be moved as long as the First Aid course is completed before vocational placement.

## Vocational Placement

Learners are required to undertake a minimum of 120 hours of vocational placement within a registered and approved aged care centre. This must occur after the student has satisfactorily completed all the other units/subjects in this qualification.

During this time, the learners are required to complete a skills workbook.

### Learners have the option to:

- **Source their own Vocational Placement providers (Melvic College Australia to check suitability) or**
- **Have Melvic College Australia assist them in arranging Vocational Placement providers near their area or**
- **Do their vocational placement through Melvic College Australia's network**
  - St. James Terrace at 294-296 Warrigal Rd Cheltenham VIC 3192**
  - Charlesbrooke – McKenzie Aged Care Group at 1 Innisfallen Ave, Templestowe VIC 3106**

Melvic College Australia will continuously look for and form partnerships with Aged Care providers in Victoria and in other states in the future.

Melvic College Australia will provide learners a Vocational Placement Pack that outlines all the requirements for finding a suitable Vocational Placement provider that will facilitate the required workplace assessments and allow the learner to complete the required vocational placement hours.

Learners are recommended to initiate contact with potential vocational placement providers as soon as enrolment is confirmed to allow sufficient time for Melvic College Australia to confirm the workplace's safety and suitability.
